 must also provide CO2 emissions data upon request.
- **Customers**: We collaborate with our customers to minimise the environmental impact of our products, particularly regarding their ultimate disposal.

Linecross is committed to complying with all applicable environmental laws, regulations, and standards. We also strive to go beyond compliance where practical, demonstrating our commitment to proactive environmental management.
